## I. The procedure for admission of applications and documents for participation in the competitive selection to higher education institutions

- 1.1. Applicants on the basis of complete general secondary education by day and correspondence forms of application submit:
- only in electronic form, exceptions defined in this paragraph;
- only in paper form:

- exercise the right to enter for an interview, exams and / or quota for foreigners to these Rules;
- to exercise the right of priority enrollment in accordance with these Rules;
- if there are any differences in the surname, first name, patronymic, date of birth, sex or nationality of the applicant in his / her documents;
- when submitting a foreign educational document;
- in case of application by foreigners and stateless persons permanently reside in Ukraine;
- in the case of submission of a document on complete general secondary education issued prior to the introduction of photopolymer technologies for their production
- in case of submission of application after the termination of the e-cabinets, if the entrant has not registered the e-cabinet before;
- if it is impossible to register an e-cabinet or to submit an application in electronic form for other reasons, confirmed by the certificate of the admission committee of the institution of higher education.

Entrants referred in the fourth paragraph of this item may submit applications electronically, with the subsequent submission of documents confirming the right to enter for the interview, on the results of entrance examinations in competitive subjects in a higher education institution and / or under a quota for foreigners who must be submitted within the deadline for receiving applications in accordance with these Rules.

## 1.2. When submitting an application in paper form, the entrant submits personally the following originals:

- identification document;
- document of the state exemplar of the previously obtained educational (qualification) level, on the basis of which the entry is made, and a copy of the annex thereof;
- \* When accepting the education of persons applying for acquired degree (level) abroad (hereinafter the Document), is compulsory the procedure for recognizing and establishing the equivalence of the Document underway according to the order of the Ministry of Education and Science of Ukraine of May 05, 2015, 504 «Some Issues of

Recognition of Foreign Documents in Ukraine education "registered at the Ministry of Justice of Ukraine on May 27, 2015 for № 614/27059
